## INVITATION TO MEMBERS OF THE PUBLIC TO AVAIL THEIR GENERATORS

The Electoral Commission of Namibia (ECN), in accordance with the Public Procurement Act, No. 15 of 2015 read together with the Electoral Operations Policy, hereby invites members of the public to avail **GENERATORS** for use during the upcoming **General Registration of Voters (GRV) scheduled to be conducted from 03 June 2024 to 01 August 2024.** 

The generators **MUST BE** in a good working order and functional and meet the following criteria:

- a) Will be subjected to inspections and testing before assigned;
- b) Must have a capacity of at least 3.5kw;
- c) Must have a tank capacity of at least 20-25 litres;
- d) **Signing of Contract**: All owners of the selected generators that meet all prescribed inspection and testing requirements, will enter into a contract of agreement with ECN.
- e) **Identity Document**: Owners must submit two certified copies of the owner Identity Document (ID copy) and a **Bank Account Confirmation Letter**;
- f) A flat rate of N\$250 per day will be paid for use of generator, excluding fuel.

Owners are requested to avail their generators at selected towns across the country as indicated in the table below:
