1. Rights of Public Entity

The Electoral Commission of Namibia reserves the right:

- (a) to split the contract as per the lowest evaluated cost per item, or
- (b) to accept or reject any quotation; and
- (c) to cancel the quotation process and reject all quotations at any time prior to contract award.

2. Preparation of Quotations

You are requested to quote for the items mentioned in Section III by completing, signing and returning:

3. Validity of Quotations

Quotations will be opened internally by the Public Entity immediately after the closing time referred to in instruction 8 above. A record of the Quotation Opening stating the name of the bidders, the amount quoted, the presence or absence of Bid Securing Declaration, will be posted on the website of the Public Entity and available to any bidder on request within three working days of the Opening.

1. PURPOSE

- 1.1 The purpose of this Request for Bid is to invite Suppliers (hereinafter referred to as "bidders") to submit bids for the supply and delivery of election materials to the Electoral Commission of Namibia (ECN), within a period of 23 September 4 October 2024.
- 1.2 This bid is open to suppliers with capacity and capability to supply and deliver Election materials conforming to requirements and standards set out in **Section 4-6** of this bid.

2. BACKGROUND

2.1 The ECN has identified the need for acquire and deliver of various election materials to be used for registration and election by Election Officials during the conduct of the Presidential and National Assembly Elections scheduled to take on the 27th November 2024 and all other subsequent elections.

3. SCOPE OF BID

- 3.1 The invitation of bids is aimed at ensuring that the following Elections materials are acquired and delivered to the ECN Head Quarters (HQ), Logistic Store within timeframe specified in this document:
 - i) 10M Bulb Extension Cables

4. SPECIFIC PRE-REQUISITES

- 4.1 Prospective bidders must be prepared to deliver a high quality product right first time and at the right time.
- 4.2 The execution of this bid requires a high degree of accuracy and quality control as the condition is exacerbated by an extremely short production window which leaves no margin for error or failure.
- 4.3 Prospective bidders must initial every page and sign the last page of this bidding document as a requirement to declare acceptance of the conditions and requirements specified in this bid.

 - v) Proof of Namibian ownership (Company must be 100% Namibian owned)

6.1.2 Quantity

6.1.4 Sample

7. ADMINISTRATIVE REQUIREMENTS

7.1 Performance References

7.1.1 Bidders must provide and attach proof (i.e. **tender or bid**) of same goods or services previously supplied and delivered for the same or similar environment supported by traceable references.

7.2 Experience

- 7.2.1 Prospective bidders must demonstrate relevant experience in providing the same or similar products or services of which a list must be attached containing:

 - iv) Period (days) taken to produce and deliver the goods or services.

7.3 Delivery Period

7.4 Bid Price

7.7.2 The bidder must qualify for each applicable stage to be eligible to proceed to the next stage of the evaluation.

7.8 Bid Evaluation Criteria

7.9 Facility inspection

7.10 Bid Disqualification
